ⁱ Pursuant to CCPA § 1798.121(d), sensitive personal information that is collected or processed without the purpose of inferring characteristics about a consumer is not subject to the right to limit use and disclosure of sensitive personal information and shall be treated as personal information.

ⁱⁱ Pursuant to Colorado Privacy Act Rule 6.10, controllers also must obtain consent to process sensitive data inferences, which are inferences made by a controller based on personal data, alone or in combination with other data, which are used to indicate an individual's racial or ethnic origin; religious beliefs; mental or physical health condition or diagnosis; sex life or sexual orientation; or citizenship or citizenship status.

ⁱⁱⁱ California's definition does not state that genetic data must be used for purposes of uniquely identifying an individual.
